Tranquilliser Questions - Avoiding Answers

Dawn Primarolo was appointed Minister of State for Public Health at the Department of Health in July 2007. In the letter below from February 1994 to Barry Haslam, benzo campaigner, David Blunkett MP, Shadow Secretary of State for Health made it clear that Dawn Primarolo had been interested in the plight of patients addicted to prescription tranquillisers.

24 February 1994

Dear Mr Haslam

Thank you for your recent letter regarding Benzodiazepine Tranquillisers.

Dawn Primarolo and myself have been taking up cases and have advised on how best the groups involved might organise a parliamentary lobby and keep attention on these issues.

We have also tried to assist through both Parliamentary Questions and raising the matter on the floor of the House, in pushing the Government to accept its own responsibilities and to take action now to ensure that it does not happen again.

This is something we will be returning to both in the House and in terms of our own future policy development.

I am passing your letter to Paul Boateng who, as the legal affairs spokesman, has specific responsibility for the litigation side of what is a national scandal.

The pertinent questions she asked on the subject were obtained recently by MP Jim Dobbin, chair of the All Party Parliamentary Group on InvoluntaryTranquilliser Addiction at the House of Commons. They show that she was aware of the following:

Tranquilliser addiction had a serious impact on health.

Addicted patients when they were being treated were being treated in psychiatric hospitals.

Children under the age of 16 were becoming addicted.

That the Department of Health was not taking effective steps to curb prescribing.

That funds were not being set aside to deal with the existing problem.

That the 1988 Committee on the Safety of Medicines advice needed beefing up.

That long term prescribing was continuing.

That women and the elderly were being disproportionately affected.

That withdrawal from tranquillisers was a lengthy process and had economic impact.

That the role played by benzodiazepine manufacturers should be brought home to them

and they should be asked to provide compensation for their victims.

That medical schools were not warning about the dangers of over-prescribing.

That the CSM guidelines were not effective.

Not all the questions below have the answers as yet, and they have been asked for, but where there are answers it is clear to see that the Department of Health and in two of them the Department of Social Security (now the Department of Work and Pensions) held little data, thereby demonstrating that for them at least prescribed tranquilliser addiction was not at all a serious problem.

Not a lot has changed over the years – the prescription levels have fallen but a great deal of over-prescribing still takes place and the slack has been taken up by Z drug and SSRI prescriptions. No-one has been compensated either by government or the drug companies. Withdrawal facilities are non-existent and the Department of Health

still believes psychiatric hospitals are appropriate. Today as part of its avoidance strategy, the department maintains that addicted patients are the same as those who get their drugs on the street.

You would think that having been appointed to the Department of Health as a minister overseeing public health, Dawn Primarolo would be more aware than any previous minister of the work that needs doing urgently. **However now that she answers questions rather than asking them, the usual rules are being followed and the usual lack of information is demonstrated:**

Jim Dobbin: To ask the Secretary of State for Health how many of those previously addicted to prescribed tranquillisers have suffered long-term impairment as a consequence of their addiction.

Dawn Primarolo: The Department does not currently collect information that enables us to provide an estimate of the number of patients who are addicted to prescription drugs.
